#### RESULT: ROBERT COOK RECOVERS \$2.5 MILLION IN TWO AUTO ACCIDENT CASES

#### JUNE 16 2022

Levinson Axelrod, P.A. Partner Robert Cook recently secured a pair of auto accident settlements in two separate cases for a combined \$2.5 million in compensation.

Here are some additional details about the cases.

#### \$2 Million Settlement for Victim Rear-Ended by Dump Truck

Rob recovered \$2 million by way of settlement for a client whose vehicle was struck from behind by a dump truck on Route 206 in Springfield Township, NJ.

The Defendants raised several challenges when litigating this case. This included claims that our client suddenly changed lanes into the truck's lane of travel just prior to the collision, and that her injuries were a progression of longstanding neck and back conditions for which she had received extensive treatment before the crash. The Defendants further alleged that our client's hip surgery, which followed a fall-related injury she suffered two years after the collision, was unrelated to the crash at issue.

Fortunately, Rob was able to successfully argue that our client's subsequent fall was the result of gait and balance problems she developed due to spine injuries she suffered in the crash. Thanks to his ability to challenge the Defendants' claims, Rob was able to ultimately negotiate a **\$2 million settlement** for his client.

#### \$500,000 Policy Limits Settlement for Victim Struck in Parking Lot

In another case, Rob secured a six-figure settlement for a client struck by a vehicle in a parking lot.

Rob's client had been standing near the rear of her vehicle when the Defendant motorist drove over part of a parking lot island and struck her.

#### RESULT: KELLEY LAVERY RECOVERS \$987K SETTLE-MENT FOR VICTIM WHO FELL IN PARKING GARAGE JULY 14 2022

Levinson Axelrod, P.A. Attorney Kelley Lavery recently recovered a nearly \$1 million settlement for a client who suffered multiple injuries after falling into a hole in a parking garage.

The defendants failed to make a fair offer pre-trial and Kelley took the case to trial. After Kelley had picked a jury and presented his case through the testimony of a medical expert, liability expert, and the Plaintiff, the defense attorneys chose to settle the claim rather than proceeding.

As detailed in court documents, Kelley's client had parked their vehicle in a parking garage located at the PATH Journal Square Transportation Center in Jersey City, New Jersey. This was the first time the Plaintiff, who intended to travel via the PATH train to New York City, had used the facility.

While walking to find the parking garage's exit to the train, the Plaintiff fell in a hole on the concrete surface of the parking garage and suffered fractures of both ankles. Defendants argued that the location of her fall was closed to the public and that the plaintiff should not have been there. The Plaintiff underwent two surgical repairs for each ankle and experienced subsequent knee issues that necessitated additional surgeries.

In a premises liability lawsuit filed on behalf

a recommendation for cervical fusion surgery, Rob successfully argued that the incident aggravated our client's prior neck and back conditions and worsened them to the point that of his client, Kelley raised allegations that the Defendants which owned/operated/managed the parking garage negligently failed to address the dangerous condition which caused his client's injuries.

Following multiple days of trial, Kelley was able to successfully tender a \$987,500 settlement from the Port Authority of New York / New Jersey and the company responsible for maintaining the garage.

#### RESULT: CELINE VITALE SECURES TWO WORKERS' COMPENSATION AWARDS OCTOBER 12 2022

Levinson Axelrod, P.A. Associate Celine Vitale recently resolved two workers' compensation cases for clients who suffered work-related injuries. The results are as follows:

#### 1. Total Disability Award for Fuel Delivery Worker

Celine secured a settlement for Total Disability benefits for a worker who suffered rib fractures and shoulder and back injuries while delivering fuel. The injuries results in the client underdoing a right shoulder arthroscopy, L5-S1 fusion, lumbar decompression, and fusion L5-S1.

Thanks to Celine's efforts, her client is entitled to receive weekly benefits for the rest of his life, as well as an initial payment of \$289,980.

#### 2. Full-Time Rate Reconstruction for Food Service Worker

Celine represented a food service worker who was injured while providing food samples to store patrons. Her client suffered multiple traumatic injuries resulting in bilateral shoulder surgeries, SI joint fusions, cervical fusion at C3-4, lumbar decompression, and fusion at L5-S1.

Celine's client received a 65% PPT award but was subject to a capped rate. However, Celine was able to successfully negotiate a rate reconstruction to a full-time work week. The award entitled her client to **\$125,580.**
